- (1) dispositive power of those shares. Through his ownership interest in Dmedia LLC, which owns an approximately 6% direct interest in Dmedia Holding LP, the reporting person also has a pecuniary interest in 588,005 shares held by Dmedia Holding LP. The reporting person disclaims beneficial ownership of the remaining 10,599,133 shares held by Dmedia Holding LP.
- (2) The option vests in three equal installments on June 23, 2018, June 23, 2019 and June 23, 2020.
